Novel is a long story written in prose, but because it is long, it differs from a short story in other ways too. One of the chief differences between a novel or short story, aside from the length, is in focus. A short story focuses on incident in a time, a novel has more range.

The length and focus make novel different from short story. Novel contains more characters, setting, and problems. So, novel become more complex in performing the life experiences.

The experiences in human life are various. One of the experiences is dream. Endaswara in the book entitled *Psikologi Sastra* (2011: 17) states "Mimpi memiliki peranan khusus dalam studi psikologi sastra. Inti pengamatan Freud terhadap sastra adalah bahwa sastra lahir dari mimpi dan fantasi." According to Endaswara's statement that dreams have important roles in psychology of literature. While Freud agrees that literary works are produced by human dreams and fantasy. It means that literary works is related to human dream. By having dream, someone can improve their ideas in writing.

Moreover, Freud (1920: 9) concludes that Dream are provoked and initiated exclusively by stimuli proceeding from the sense or the body, which either reach the sleeper from without or are accidental disturbance or his internal organs. It can be concluded that dream happen to human during sleep. The content of dream itself usually influenced by their internal organ such as sense or their feeling. Dream is one of the human's act. Dream happens in human during their

sleep. It can influence human behavior because in dreams contains many representation of conflict in human daily life.
