CHAPTER I

INTRODUCTION

This chapter presents introduction of this thesis. In contains the background of the study, statements of the problem and purpose of the study. It will be continued to the limitation of the problem, significance of the study and methodology. The last part is organization of the study.

1.1 Background of the Study

- Drama is a literary form supported by the most ancient tradition, firmly embedded in the social customs of cultures throughout the word, and well known for the excitement and enthusiasm it produced both in performers and spectators (Moody, 1971:62). Drama is a peculiar literary form, in that it may be treated as literature to be read privately, or as theatre, to be seen in public performance (Little,1966:112).
- Before analyzing drama, we should know its elements. In drama there are two elements; those are extrinsic elements such as the social background of the author's lifetime and the intrinsic element, which include theme, plot, character, characterization, and setting. Enjoying literature especially drama, we are able to know the plot of each conflicts in the drama.
- In this study, drama is chosen for her study since drama deals with truths, problems and conflicts of human being. The writer chose *King Lear* as one of William Shakespeare's plays.
- However, this thesis chose one of William Shakespeare's works because he has been known to be the greatest playwright that the world has ever had. He wrote many of literary works like novels and plays most of which have become masterpiece. The names of his daughters are Goneril, Regan, and Cordelia. King Lear will give his kingdom to his daughters. He called his three children to find out which one loves him best. Goneril and Regan say they love so much, and Cordelia says, that she cannot say like Goneril and Regan. He is very shocked by what Cordelia said. One day Lear goes from his kingdom because Goneril and Regan do not love him.
- King Lear is chosen as a topic of discussion for several reasons. Firstly, this drama is widely analyzed; therefore the writer has many references to use as a starting point and reference to analyze the play.
- By studying this story, we are able to know the importance of the conflict in the play. We can identify the kinds of the conflict in the play. Thus, we cannot ignore the conflict, because, the writer concludes that there is no story without conflict. King Lear's conflict is interesting because among others, there conflicts of young people's
