CHAPTER I

1.1 Background of the Study

Nowadays art can be seen in the essence of the expression of human creativity depend on human being themselves how to convey their ideas, their sensation or their feeling in a manner as effective as possible. When reading poem of course the reader gets the new vocabulary, can translate that poem, understand that what event that happened behind the poem, and know about the purpose of the poem, so reading poem is not useless but it is very usefull for the reader that read it because there are many advantages in it.

Wellek and Warren stated that a poem exists in the reading aloud leads to the weird (1956:144). Basedon the Wellek and Weren's view it can be concluded that reading poem must be slowly. Because by reading slowly, the reader can understand the meaning of the poem, hence the reader must read slowlyto get the meaning of the poem, never read fast when reading poem because it makes the reader be confused and don't know about the meaning and the purpose of the poem exactly.

In every line of the poem has their own imagery, more over can be every word has intended meaning in a poem depend on the context. Imagery describes about the meaning of the word in every poem. It can be seen from Roberts and Jacobs's view; the contribution of the poem is language, imagery, rhythms, ideas, and all of the other aspects that make it as poetry and get the meaning of it (2002:521), so many lesson can be learned in a poem because many aspects that contained.

Usually poem conveys or expresses the author's life. There is connotative meaning in every word of the poem. Poem contained a message and description of the situation or condition. The writer focus on poem with titlle "The Road Not Taken" and "Stopping By Woods On A Snowy Evening" by Robert Frost published in 1916 and 1923. This poem on the Mountain Interval of Robert Frost collection.

The researcher chooses those poem because in "The Road Not Taken" and "Stopping By Woods On A Snowy Evening" contained several imagery, beside that, those poem is very interesting. Not only that but also those poem explained about two ways that the speaker choose, Robert Frost wrote this poem to intend of life in the speaker of the poem and the dilemma because the speaker of the poem must choose one of the ways to the future of life and keep the promise that the speaker has, as the researcher know that promise is debt and the debt must be fulfilled in order not to make anyone feels dissappointed.

Robert Frost is one of the greatest poets in the United States, almost of his poems describe about life in rural New England not only that but also about social and philosophy. Robert frost is one of the most populer american poets, especially in 20th century. Frost often receiving honored during lifetime, frost also getting four pulitzer prizes for poetry. In 1924 frost won Pulitzer Prize for the book with titlle " New Hampshire and won additional pulitzer in 1931. In 1939 frost reveiving Gold Medal by The National institute of arts and Literature. Not only that but also in 1960 Frost received the united state Congressional Gold Medal againt. very much appreciation that frost received, So that why the writer used poem of the Robert Frost as the object to analysis.

Ricards stated in Wellek and Warren's that too much importance has always been attached to the sensory qualities of image.What gives image efficacy is less it is vividness as an image than it is character as a mental event peculiarly connected with sensation (1924:187). Base on the Ricards's in Wellek and Waren's view image efficacy coherence with sensation and many image that contained in a poem so that image and sensation have a relation.

Murry stated in Wellek and Weren(1956:188) simile and metaphor as associated with the formal classification of rethoric advises the use of image as a term to include both. Base on the Middleton Murry in Wellek and Warren view's to classification rethoric advises if uses image to include simile and metaphor.

Analyzing poem can use some literary devices. The researcher would like to analyze this poem with imagery theory, because in researcher's opinion, imagery is the suitable device to analyze those two poem, by using the imagery device the researcher can analyze the poem in detail condition because imagery analyze every part of the poem, there are kinds of imagery: auditory imagery, visual imagery, olfactory imagery, gustatory imagery, tactile imagery, organic imagery, and kinestetic imagery.

1.2 Statement of the problem

After reading "The Road Not Taken" and "Stopping By Woods On A Snowy Evening" poems based on the background of the study above, the researcher has two questions in the research. Those questions can be formulated as follows:

- What kind of the imageries used in "The Road Not Taken" and "Stopping By Woods On A Snowy Evening"?
- How do the imageries contribute to the total meanings of "The Road Not Taken" and "Stopping By Woods On A Snowy Evening" ?

1.3 Objective of the study

1.7.1 Poetry
