## **CHAPTER V**

## **CONCLUSION**

After analyzing the internal conflict in Eveline and her failure to fulfill her sel-actualization, it can be taken some conclusions here. Relating to conflicts that arise within Eveline is the result of her inability to accept the real facts of her condition of life. She can not accept the reality of her life. She makes a deficiency in her needs as a problem to be solved because it makes her life miserable. Then, the problem arises a desire to fulfill the needs for love, safety, a sense of belonging and a sense appreciated by escaping from her family.

Basically those needs are basic needs that must be met first before someone wants to realize the need for self-actualization. In Eveline, the needs for security, love, a sense of belonging and appreciated are not being met due to conditions and parenting of her family can not provide those needs. Her family wasn't complete since her mother and her brother, Ernest died. Eveline lived with her father and her brother, Harry. Her father often abused her and less attention to Eveline. Moreover, when many of her friends are gone then Eveline doesn't have someone to share. Feeling afraid to her father and loneliness always covering her.

When someone can not get the needs in himself, then he tries to get them from other people or in other place. So, when Eveline met frank, a very good man and cares to her, then she believes that Frank is her savior, who gives the needs that had not met all this time and able to fill the void in her life. Eveline wants to achieve happiness which she thought could be achieved if she goes out of her life

now. Eveline thinks that escaping with Frank is the most appropriate solution to her problem and she can realize her self-actualization. Lack of fulfillment of needs for love, safety, a sense of belonging and self-esteem led to tension in the form of low self-esteem, a sense of unappreciated, lack of confidence and fear in taking important decisions in her life. Eveline also feels very tied to her past because there is a part of her past where Eveline ever felt safe, loved and protected. That is, when her mother was still alive, which her father could be very nice and her friends who accompanied and shared with her.

Eveline's family bonds connecting with her family in this case with the father and his brother is very strong, where the condition can be happened because since her mother died and earlier Eveline asked to promise to be with his family then she has the responsibility to her family. She had to work hard for them. Those conditions has caused inner conflict within Eveline. A conflict in which she had to choose between the desire for happiness and discover her self-identity and staying with her family and take care of them as she had promised to her mother.

Therefore, when Eveline decided to remain with her family, then it can be understood that the decision was taken because of her helplessness to leave the family that had become her responsibility, Eveline's fears about her future with frank that may not seem like the man who loved and love her. Eveline's decision is motivated by her past that had shaped to her way of thinking and her attitudes in making decisions that certainly has made her wish to achieve her self-actualization can not be fulfilled.

So, that it can be said that when a person wants to achieve self-actualization, shows his or her potential, self-existence which is the highest level of needs of a human being, then it takes a long process. Because he has to fulfill the lower needs such as physiological needs, love needs, safety needs and esteem needs. and the most important is, he has to have self-accepted or know his or her self-potential.
