# **CHAPTER III**

# **METHOD OF THE RESEARCH**

This chapter discusses systematically method included The Nature of the Research, The Source of the Data, The Selection of the Data, and The Data Analysis.

### 3.1 The Nature of the Research

There are two methods used to analyze the research qualitative and quantitative methods. The research uses descriptive data and verbal expression for the observed is called qualitative method (Bogdan & Taylor in Sulistiai, 2012:9). Hidayah (2007:33) also defines that quantitative methods are the data collect with a numeral. Arikunto (2006:12) states that in quantitative methods, the result better uses table, graphic, picture, or others.

This research uses descriptive qualitative. It can be descriptive because this research describe about the metaphors are used in "Crossing the Bar" clear. The research process is, for many of us, just the way we do things. There are many ways to get much information. They are: a) read books or articles in magazine, journals, b) search an encyclopedia CD-ROM, and c) even explore the internet World Wide Web for information.
