

CHAPTER IV

FINDINGS AND DISCUSSION

4.1. Immigrant in NOW Corpus

From the data that taken from NOW Corpus during Obama on January 20 2009 to January 20 2017) and Trump’s presidency from January 20, 2017 to the present time (May, 30 2018), the writer took the ten adjectives from both eras that collocate with the noun [immigrant]. Below are the results from the NOW Corpus during both Obama’s and Trump’s presidency:

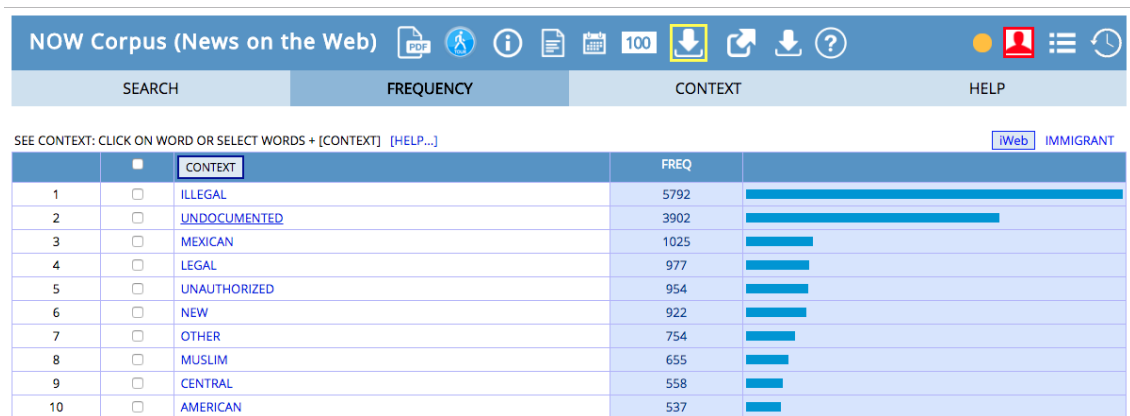


Figure 4.1. The tenth adjective Collocation of Obama’s Presidency

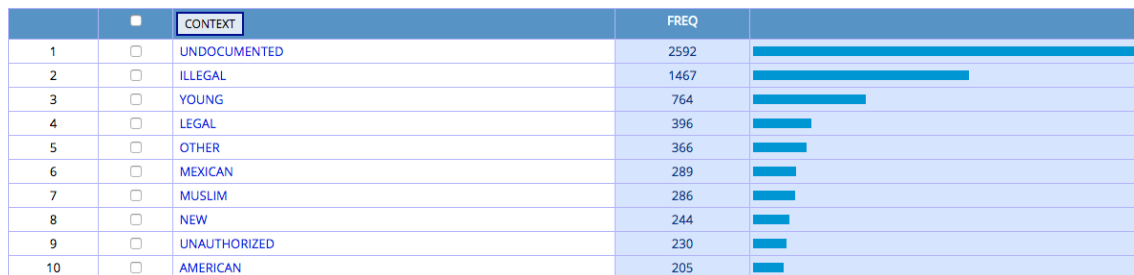


Figure 4.2. The tenth adjective Collocation of Trump’s Presidency

4.2. The Differences between Obama's and Trump's Presidencies

After the results of the adjective collocation have already got, the writer mark them off into a table. The table below represents the data of both presidencies.

The words that written bold were the similar between both presidencies, while the words that were not in bold was the word that did not appeared on both era. The first column shows the adjective collocation during Obama's presidency and the second column shows the Trump's presidency and the data were taken from January 20th 2017 to May 30th 2018. Although there is no significant difference between the words that is appear in the first column which shown the results of the corpus during Obama's presidency and the second column where Trump became the president, but still a different words appeared on them.

The table above showed the appearance of the different collocation as *central* on the first column and *young* that appeared in the second column and did not show up on the first column. Meanwhile, other nine words that appeared were the similar words. The words order of adjectival collocation toward [immigrant] was also different. The difference word order can be caused of how such words were commonly used for the topic of certain news.

Either Obama's or Trump's presidency mostly discuss about *illegal* and *undocumented* [immigrant]. It can be seen on the table during Obama's presidency, the collocation of *illegal* and *undocumented* towards [immigrant] show up on the first and the second number. Meanwhile, the words order of *illegal* and *undocumented* on the second column, were the opposite of the same words that occurred on the previous era and made the collocation of *undocumented* appeared first and then continued by the adjective of *illegal* on the second number. The adjective of *Mexican* was on the third number of the first column but it decreased drastically to the sixth number on the second column and the third number on the second column was the adjective of *young*. *Legal* was on the fourth number of both era. On the first and second column, the fifth number was *unauthorized* and other. The adjective of *new* was on the sixth number order during Obama's presidency and it decreased two numbers below on the eighth number of Trump's presidency.

The adjective of *other* this adjective increased two numbers on the second column from the seventh number to the fifth. *Muslim* collocation was one number ahead from the first column. Meanwhile, the collocations of *central* were on the ninth of the first column but it did not appear on the second column, as the collocation of *young* on the second column and the ninth of the second column were found the collocation of *unauthorized*. However, the collocation of *America* was on the tenth number during both Obama's era and Trump's era.

The similar adjective collocation as *illegal*, *undocumented*, *Mexican*, *Legal*, *unauthorized*, *new*, *other*, *Muslim*, and *American* from both presidencies. Meanwhile, the different collocation of *central* [immigrant] during Obama tends to be a good connotation than in Trump's presidency because there were many [immigrants] from the *central* America who came to the United States as a legal [immigrant]. Furthermore, the appearance of the word *young* tends to be a bad connotation towards [immigrant] because the huge number of the *young* [immigrant] who came to America illegally or they were born by an *undocumented* parents.

4.2.1. Immigrant during Obama’s presidency

The table below shows us the results of the adjective collocation towards the noun of [immigrant] that found from the NOW Corpus of the Obama’s era

The words *Illegal* and *undocumented* appeared on the top of the list of [immigrant] collocation during Obama’s presidency. This happened since *illegal* and *undocumented* [immigrant] was the biggest problem of the United States according to the Brookings’ research (2017) and both of them sometimes worried the government the fact that they did brutality and a criminal thing which made the policy of *illegal* [immigrant] mostly discussed and developed. The words *illegal* also mostly found they collocates with *Mexican*, which means there are many *illegal* [immigrants] that are coming from *Mexican*, see number 1 and 10 on the figure 4.3 the people from the country that directly adjacent with America. During Obama’s era, *illegal* [immigrant] was not too discredited by the government since he permitted the *illegal* [immigrants] to stay in America with their children and he still allowed the young *illegal* [immigrant] to work in the United States.

Meanwhile, the results of the adjective collocation of *undocumented* towards [immigrants] found that five over ten news shown the appearance of the word *undocumented* on the two words before and the noun of [immigrant] followed by the nationalism of where those [immigrants] belong such as Ulghur, Chinese, Mexican, African, and Hispanic, see figure 4.5. Which means, these *undocumented* [immigrants] came from and they threatened to be deported. Obama was the American president who was famously labeled as the “deporter in chief” because has deported more than 2.5 million of the *undocumented* [immigrant] who are involved in crime by critics in the immigrant-rights community, see figure 4.6 (Marshall, 2016). Thus, during his

leadership he never found or said a bad thing towards *undocumented* [immigrant].

The third number of [immigrant] collocation was *Mexican* [immigrant]. The collocation of *Mexican* [immigrant] was on the third number ordered during Obama's presidency, unlike Trump's era where the number position was decreased on the sixth number. As he labeled as the deporter in chief, Obama has deported more Mexican [immigrants] than any other presidents because they came to America illegally and most of them found doing crimes and bringing drugs to America, especially in Arizona where the *Mexican* [immigrant] attacked them from drugs and violence, see figure 4.7. The adjective collocation of Mexican [immigrant] did not treat discredited during Obama.

Under Obama’s administration, the number of an *unauthorized* [immigrants] living in the United States was on the lowest level for the recent decade. According to the data that is taken from Pew Research Center (2017), the number of *unauthorized* [immigrants] in the United States stayed at the number of 11.1 million between the year of 2008 and 2014. Along the year of 2008 to 2014, the *unauthorized* [immigrants] from Mexico decreased but those who came from other regions worldwide increased. Although the number of *unauthorized* [immigrants] decreased, Obama still imposed a deportation for them.

He deported several number of the *unauthorized* [immigrant] by made some immigration enforcement priorities of where they involved. According to Bipartisan Policy Center (2017) which recorded the differences in policies carried out by Obama and Trump, there are three priorities made by Obama to handle the problem of immigration during his era. The priority number one is the [immigrants] who were threatened to national security, border security, and public safety; engaged in or suspected of terrorism or espionage, or who otherwise poses threat to national security; convicted gang members; appended at the border attempting to unlawfully enter the country; convicted of a felony (other than offenses related to person's immigration status) or aggravated felonies. Priority number 2 as follows: The misdemeanors and immigration violators who convicted of three or more misdemeanors (other than minor traffic offenses related to person's immigration status); the immigrants who

convicted of a significant misdemeanor (domestic violence, sexual abuse/exploitation, burglary, unlawful possession or use of a gun, drug distribution or trafficking, DUI); persons who entered or reentered unlawfully after January 1, 2014; persons who have significantly abused visa programs. The last priority was addressed to other immigration violators and the persons with a final order of removal issued on or after January 1, 2014. Figure 4.12 will show you the impact of Obama's policies towards [immigrant]

Meanwhile, an *American* [immigrant] during Trump's presidency means the American who wanted the immigrant adjusted the American's spirit by obeying the policies, being a good immigrants and making themselves as a *legal* [immigrants]. Although legalizing the *unauthorized* [immigrant], as a legal *American* [immigrant] need huge amount of money, being a legal *American* [immigrant] have several benefits, they can vote, received social services from federally funded programs, social security, and held a United Stated passport. The collocation of *American* [immigrants] also collocates with other nouns. Because during his era, there were found many mixed

nationalities immigrants that moved to America as African American immigrants, Central American immigrants and Latin American immigrants, see figure 4.37.

4.3. Immigrant Associated with the Adjective Class

The following semantic types are associated with the grammatical class Adjective in English. Therefore, the writer took the ten selected data or adjectives then classified into the Dixon's (2005) theory of adjective. Below are the adjective collocation that occur during Obama's presidency:

4.3.1. Semantic Categories on the Obama's era.

The table below represents the semantics type of the grammatical class adjective of [immigrant] according to Dixon's classification during the Obama's presidency from January 20th 2009 until January 20th 2017.

After gathered the data, we can see on the Table 4.1. there were three genres over eleven Dixon's classification of collocation that mostly used that showed up on each era. The highest numbers of adjectives are found on the value classification with the adjectival collocation of *illegal*, *undocumented*, *legal*, *Mexican* and *unauthorized*. The collocations of *undocumented*, was a bad value of [immigrants] but *legal*, *illegal*, *unauthorized*, and *Mexican* were the good value.

The context that appeared from the *undocumented* appeared on the two words before the noun of [immigrant] which then followed by the nationalism of where they belong. Obama famously named as the “deporter in chief” since he has deported more than 2.5 million of the *undocumented* [immigrant] who are involved in crimes. It quoted by <https://abcnews.go.com/> with following statement President Barack Obama has often been referred to by immigration groups as the "Deporter in Chief." Between 2009 and 2015 his administration has removed more than 2.5 million people through immigration orders, which doesn't include the number of people who "self-deported" or were turned away and/or returned to their home country at the border by U.S. Customs and Border Protection (CBP).” He did not discredit the *undocumented* [immigrant] of America but he agreed that those *undocumented* [immigrants] were giving nothing but mess to America.

Meanwhile, the collocation of unauthorized towards [immigrant] on the era of Obama did not have a bad connotation as in undocumented. During his era, the collocation of unauthorized [immigrant] was meant the number of the unauthorized [immigrant] was decreased. This claimed by <http://www.pewresearch.org/> which explained “The number of *unauthorized* [immigrants] living in the United States in 2015 fell below the total at the end of the Great Recession for the first time, with Mexicans continuing to represent a declining share of this population, according to new Pew Research Center estimates based on government data.” This is clearly seen that even if the word *unauthorized* sometimes claimed as the bad value, it was not in the Obama’s presidency.

As quoted by <http://dailycaller.com/> about *illegal* [immigrant], where it explained about how Obama’s administration through the *illegal* [immigrant] which written there “In June of 2012, Obama rolled back enforcement of immigration law, and allowed more than 500,000 younger *illegal* [immigrants] to work in the U.S. — despite the nation’s high unemployment rate. Subsequently, Obama scored 71 percent of the Hispanic vote in the 2012 election.” Obama did not discredit the *illegal* immigrant during his era. Just as what already done with the collocation of *unauthorized* [immigrant], the words

illegal were not merely have a bad connotation. It may have a good connotation as what is already happened during Obama's era by ease the *illegal* [immigrant] to work in the United States.

Unlike the collocation of *legal* that considered as the good value of the noun [immigrant] because of Obama's policy where he wanted to legalize the undocumented, illegal, or unauthorized [immigrant] although he was failed and left his legacy behind Trump's. As <https://abcnews.go.com/> written which said "The president's order will also extend legal status to a larger universe of so-called Dreamers, who first came to the U.S. illegally as children and either are attending school, have graduated high school or have served in the military. As many as 270,000 more undocumented immigrants will be able to apply for legal status under the program, which Obama first unveiled in 2012, administration officials said."

Meanwhile, during the era of Obama, the year of 2009 to 2014, the number of undocumented *Mexican* migration to the United States was decreased. The <https://www.usnews.com/> noted on its page "The number of illegal immigrants in the U.S. peaked at 12.2 million in 2007 around the start of the financial crisis, falling to 11.3 million in 2009, breaking a decades-long rising trend. The report suggests that the immigration lull is the result from a weak economy and a decrease in Mexican immigrants." Therefore, the adjective collocation of *Mexican* [immigrant] was grouped by the good value because the good new of the *Mexican* [immigrants] to the United States was decreased drastically.

The classification of other are found the collocation of *other*, *central*, and *American*. Other collocation towards immigrant during Obama's presidency showed up that it appear in conjunction with another random words such as other children immigrants, other nationalities, other legitimacy, and so on. To clarify this statement, we can see the news pieces delivered by <http://www.latimes.com/> "Khan and Dhillon argue that they and other South Asian immigrants helped make the company into what it is today, and are being treated as employees who can be tossed aside instead of independent store owners". This example clearly shown that the collocation of *other*

[immigrants] did not classified into the eleventh Dixon's classification but other.

Muslim collocation categorized by the classification of human propensity which means the natural humanity preferences which laid on each persons. Therefore, the collocation of Muslim [immigrant] tends to get bullied or hated by American people. Quoted from <https://splinternews.com/> about Trump's campaign during Obama's presidency "In the U.S., we can already see the impact of Trump's campaign at lower levels, like an increase in bullying and harassment of Muslim and immigrant students in public schools, and an upsurge in anti-Muslim hate crimes in the period since he began his campaign and since he started publicly demeaning these groups. Two weeks ago, his candidacy inspired former KKK leader David Duke to run for a Senate seat in Louisiana." Therefore, the adjective collocation of *Muslim* [immigrants] grouped into the human propensity.

Meanwhile, the American [immigrant] during Obama's era did not have the specifics things and it has several federation between American and other people from different countries as American and Haitian [immigrant], Asian American Pacific islanders [immigrants], African American, Sudanese American, etc. that mostly discussed. Therefore the collocation of American [immigrant] classified into the other classification. We can see on this following news that quoted from <https://www.washingtontimes.com/> "House Republicans said Wednesday that they intend to swiftly pass a domestic-violence law and remove the issue from election-year politicizing, though the Democrat-led Senate is prepared to vote on a different bill on the issue Thursday. It's not clear yet how the two bill, the Senate version contains provisions related to homosexuality, American Indians and immigrants that the House bill will not be reconciled, though each party said the issue should not become a political football and accused the other of trying to do just that."

New [immigrants] was classified into the age classification, since it means the year or period of a certain [immigrant] was being an [immigrant] as written by Roman Gil on the <http://thecnnfreedomproject.blogs.cnn.com/> "In May, the American economy added the insignificant number of 38,000 jobs.

America is overpopulated with over 311 million people (nobody knows how many illegal aliens) and cannot support its own population, but millions of new illegal and legal immigrants arrive each year. There is no industrial plan to bring back the millions of jobs and industries that global corporations exported and continue to export.” He wrote on his opinion that each year there were many *new* of both illegal or legal [immigrants] who come to America.

The appearance of central collocation of [immigrant] during Obama’s presidency caused by the amount of [immigrant] that too much to be on the Central America, southernmost North America region that lying between Mexico and South America and consists of seven countries, they are Panama, Costa Rica, Nicaragua, Honduras, El Salvador, Guatemala, and Belize (Woodward & Bushnell, 2018). “Seeking asylum is not a crime, and they are being treated like they’re criminals,” said Helene Tatum, a Missouri-based immigration lawyer who volunteers at the South Texas Family Residential Center, a facility in Dilley set up by the federal government to house many of the immigrants from Central America.” Those words quoted from <https://www.mystatesman.com/> shown that the number of [immigrants] which in Central America were increasing.

The data that has been gathered during Trump’s, found the difference results from Obama’s. The results were the classification of value has the greatest number among all but the number of classification of age and other has two kinds of collocation. Bad values of [immigrant] as *undocumented*, *illegal*, and *unauthorized*, *Mexican*, and *Muslim*, yet the good value of *legal* not only occur at the era of Obama. They also continued to Trump’s era. Those three of the *undocumented*, *illegal*, and *unauthorized* were the same meaning.

According to <https://nypost.com/> that explain “Consider the hot topic of the moment: illegal immigration. The syndicate that distributes the column you are reading follows the AP Stylebook, which says that I am not allowed to refer to “illegal immigrants” (i.e., people who migrate illegally), but I can refer to illegal immigration (i.e., the act of migrating illegally). Kathleen Carroll, then the senior vice president and executive editor of the Associated Press, explained that the change was part of the AP’s policy against “labeling people.” Many news outlets followed suit, using terms like “unauthorized” or “undocumented” to describe immigrants formerly known as illegal.” The bad connotation of them appeared

since those three adjective collocations of [immigrants] suspected by Trump that they came to America by bringing drugs and doing crimes and they also accused as the rapists. The term of “animal” and “alien” were labeled to [immigrants] who come to America to *illegal, undocumented, or unauthorized* [immigrant]. The problem of them occurred because either *undocumented, illegal or unauthorized* [immigrant] were found doing crimes and they begged president to protect them with a legally rights or aids as what have done in Obama’s presidency.

The use of *Mexican* [immigrant] became the bad value during his era because Mexico City considered sends its people to America illegally. Trump’s believed that when Mexican sent its people, they were not sending its best they rather send the criminals illegally as quoted from <https://edition.cnn.com/> “In June 2015, he said "they're not sending their best." In April 2018, he (Trump) said, "they're not putting their good ones." And in both cases he brought up rape. It's clear he feels vindicated in that original claim despite the backlash at the time. Once he has said something vile like *Mexican* [immigrants] are rapists or something specious like millions of Californians voting illegally, he won't be dissuaded from bringing it back up in the future.” Trump promised to build a Mexico and United States barrier or a wall around their borderline in order to prevent an illegal aliens come to United States who will seize the opportunity of jobs towards American people.

Just as Mexican, the Muslim [immigrant] were banned to come to America because of its bad connotation towards Trump who judged them as the radicalized religion and he wanted his country to be saved by making a ‘Muslim-ban’ policy which prohibit the Muslim-majority countries travel to America. Through <http://www.postbulletin.com/> which explained “Backlash against the H-1B visa has been one part of the furor over U.S. immigration policies that has grown since President Donald Trump began campaigning for the presidency on an anti-immigrant platform. Fissures have widened in public opinion over Trump's so-called "*Muslim* ban" on [immigrants] from Muslim-majority countries, over the admission of refugees, and over the unresolved fate of DACA, the program that has let millions of foreign citizens — brought to the U.S. illegally as children — remain in the country.”

The good value of legal [immigrant] referred to his purpose towards the previous president, Obama who failed to legalize the huge number of illegal [immigrant] and Trump promised to continue his program. “The new poll finds that 60 percent describe Trump as “mentally unfit,” 62 percent call him “generally dishonest,” and 63 percent say he “is a racist.” In a mid-February AP-NORC poll, 57 percent of all adults in the U.S. said they believe Trump is racist. The poll also found that young people overwhelmingly support watching out for minorities: 69 percent favor a pathway to legal status for immigrants brought to the country illegally as children, 59 percent favor protecting the rights of LGBT citizens, and 58 percent say the same for Muslims.” Quoted from <http://www.nwherald.com/> it was clear that Trump has ran the legacy that left by Obama as the previous president.

Unlike on the Obama’s era, the collocation of *other*, was on the other classification because the term of other described [immigrants] subjectively and there was not found the suitable classification according to Dixon’s. We can see the details on the figure 4.27 which there are some nouns that involved towards *other* [immigrants]. According to <http://www.baltimoresun.com/> about *other* [immigrant] that written there “Every day Trump provides new evidence to demonstrate the colossal misjudgment that the American electorate, or at least the Electoral College, made more than a year ago in giving the presidency to a man who pledges to “make America great again” but fails to understand what and who have already done to do so. Much of the “Trump base” that reveled then in his crude and blunt rhetoric about Latinos and *other* minority [immigrants] may still remain firm, pleased rather than repulsed by what he says and how he says it.”

American [immigrant] rather decided as were classified into the other classification since the American [immigrant] mostly discussed randomly, see Figure 4.37. The writer quoted the news that is written by one of the website, <https://www.nbcnews.com/> from the NOW Corpus’ context “Moy noted that if not for the support of these Chinese benevolent societies, it was unlikely that Cheung or most of the other Chinese-American pilots would have been able to fund their training or have access to an airplane due to both financial issues and the prevalent racism of the era. The typical civilian pilot was more like the

reclusive millionaire Howard Hughes, than a Chinese *American* with [immigrant] parents, according to Moy. While Cheung's father was a successful produce buyer for markets in Los Angeles' Chinatown, many of her classmates came from more middle class backgrounds.

Thus, the classification of age was not alone, the appearance of *young* stands with *new* [immigrant] collocation and they were classified into it. The classification of age means the age of a person or the time period. The appearance of the word *young* during Trump's presidency indicated that there were huge number of young [immigrant] who came to America and they suspected as the young undocumented [immigrant] who migrates to the United States. The passage below which written by <http://www.foxnews.com/> represents the *young* [immigrant] during Trump's presidency "The maneuver would allow the House to consider a conservative immigration plan drafted by House Judiciary Committee Chairman Bob Goodlatte, R-Va.; the Democrats' DREAM Act, backed by Rep. Lucille Roybal-Allard, D-Calif.; a plan from the House Republican leadership; and a bill by Reps. Will Hurd, R-Texas, and Pete Aguilar, D-Calif. The Hurd/Aguilar measure would grant legal status to many DACA recipients, the *young* illegal [immigrants] who came to the U.S. as children and whose status is now threatened by a combination of Trump action and congressional inaction."

However, the collocation of *new* means the recent [immigrants] who has just migrates or moved to the United States and they have to understand the rules or policy of "flat ban" which was initiated by Trump. This delivered by <http://www.mcclatchydc.com/> "Trump fired Sally Yates, an Obama administration holdover, days into the new term, after she refused to defend the administration's *new* policy to ban [immigrants] from Muslim-majority countries. It turned the then-acting attorney general into a star among many Democratic and liberal voters.

4.4. Interpretation of the Results

The table above represents the similar and differences grammatical class of adjective collocation of Dixon's theory towards Obama and Trump's presidencies. Beside the collocation, the classification of both presidencies also found the differences. As the appearance of *central* on Other's classification and *Muslim* on the Human propensity classification of Obama's and the collocation of *young* on Age's classification and the collocation of *Muslim* on the Value classification of Trump's. The cause of why it found difference on the classification can be determined through KWIC (keyword-in-content) of several data from the NOW Corpus. It helped the writer classified the type of adjective collocation. Meanwhile, the differences of adjective collocation that found on the top tenth number of data that has been shown automatically from the NOW Corpus.

Obama and Trump also from the difference political party. Obama was into the Democratic Party and Trump was on the Republican Party. Both parties have their ways to handle immigration problems. In the United States, Democratic Party is known as a liberal party who believed that politics is not always about power rather an individual freedom since their beliefs in freedom which always under threat. They create several suggestions to protect freedom such as the police, civil rights, human rights defenders, regional autonomy, freedom of speech and the press, and so on. Unlike Republican Party which consisting of several conservatives people who believed that the current situation was the right situation since it has been selected and improves through a long history and tradition. They took a skeptical attitude towards change. In determining the good and bad things, they often refer to tradition and history. The tradition as mentioned can be in the form of local culture or religion. This was in sharp contrast to the liberalist thinking. Remember, they think humans are rational beings, so that humans can determine for themselves what is good and what is bad, so that there can be a variety of views on a problem.

As Obama's presidency, the immigration policy was to call for the systematic reform of immigration system for the residents who come to the US illegally to have a pathway to legal citizenship (Frumin, 2013). According to Frumin from Obama's remarked who said that fixing the broken immigration system takes time. Especially when he wanted to allow the bright young people who came to the US as students and asking permission to become full citizens. Frumin gathered the data from The Public Religion Research Institute and found the 73% of Democrats supported the concept in giving them pathways compared to the other 63% of the whole American for the late 2013. At the same year, Democrats passed the border security, economic opportunity, and immigration modernization act of 2013 (S.744) that would reform the immigration policy and allowed citizenship for *illegal, undocumented, or unauthorized* immigrants in the US and improved the immigrant lives who currently living in the United States.

The immigrant political positions against the social policy also reformed the immigration system and allow them a pathway to citizenship. Immigration reform in the US used in regards to change the current immigration policy of the

United States. There were also several social policy of Democratic Party such as upheld network neutrality which neutral the Internet providers to treat the user with the same policy without discriminate them, implemented campaign finance reform and electoral reform in order to eliminate the money politics towards primary campaign, supported the same-sex marriage and civil union. Allowed legal way to abortions and gave the women's reproductive health care although there were anti-abortion laws that have been forced since 1900. Supported for gun background checks and stricter gun control regulations, improved privacy laws and decreased the government surveillance, opposed in torturing, until recognized and defended Internet freedom worldwide were his social policy towards the political positions of Obama's presidency.

Meanwhile, Trump's political party was into the Republican Party. As mentioned above how Republican Party political run, it divided on how to confront immigration between allowed migrant workers and a path to citizenship, versus a position focused on securing the border and deporting illegal immigrants (Gould, 2003). Deporting illegal immigrant then supported by Trump who proposed a wall building along the southern border in order to avoid huge number of illegal immigrant from Mexico. Under his administration, he obtained a "zero-tolerance" which means a policy that imposed a strict punishment by eliminating several number persons intentionally. His policy can be found when he did a family separation towards *illegal, undocumented, and unauthorized* [immigrant] who caught up at the border of America and Mexico. Beside that, Mr. Trump also labeled them as an "animals" rather than a human and this case was never found during President Obama's presidency.
