

CHAPTER III

RESEARCH METHOD

This chapter describes how the researcher analyzed the research. The researcher briefly describes the research method that being used in order. This chapter also designed to help the reader to understand deeper on how the research had been done. Thus, this research remains clear and transparent for all readers.

3.1 Research Design

Research design is the basic plan on how a research will be processed. Kumar had explained about research design in his book titled *Research Methodology*, he said that, “a research design is written plan for a study. It communicates the intentions of the researcher, the purpose of the study and its importance, together with a step by step plan for conducting the problem” (2008:30). Thus, research design is one of the important things to be paid attention on.
