## **CHAPTER I**

## **INTRODUCTION**

This chapter present background of knowledge, statement of problem, purpose of the study, significant of the study, scope and limitation, organization of the study and the definition of the key term.

## 1.1 Background of Knowledge

Literature has rich definition, one of them literature, it expression by Klarer that:

Literature" is derived from "littera" (letter), which is the smallest element of alphabetical writing. The word text is related to "textile" and can be translated as "fabric": just as single threads form a fabric, so words and sentences form a meaningful and coherent text (Klarer, 2004:14).

based on Klarer opinion can be understood that literature is can of literary work which is as application as writing skill that has full meaning.

The others opinion is also explained by Quinn that literature usually understood to refer to "creative" work in the form of poetry, fiction and drama (1932: 243). Looking Quinn's quotations can be understood that literary work is skill to create something new in writing. Usually literary can be application such as novel, short story, drama or poetry.

Literature is divided into two kinds, those are fiction and non-fiction. According to Abraham, fiction is any literary narrative, whether in prose or verse, which is invented instead of being an account of events that in fact happened. In a narrower sense, however, fiction denotes only narratives that are written in prose (1999:94). Based on Abraham states, fiction can be understood that it is included literary work in writing, fiction is written by writer based on the experience of the writer whereas nonfiction is opposite of fiction which define, it is literary work but it is written by imagination of the writer.

Novel is kind of narrative fiction, it evidence by Quinn that Novel is usually a book-length fictional prose narrative (1923:293). Novel can be the most popular of literary work because when people read the story of novel, they will be easier to understand the value directly. Moreover, novel often gives additional value that is because novel possible describes the life of certain people at certain time which makes it challenging and interesting to know the story. After reading novel, people get some advantages such as moral value, wisdom or good philosophy of life that can be brought in the better living. Moreover, Literature sometimes is not always entertained but also it may be able to be as the tool to overcome the problem better because it is created by writer with particular purpose.

Literary works have good relationship to social problem. Discrimination is one of problem of society which still around us. According to Smith that discrimination consists in treating people differently on certain forbidden grounds like race, sex or religion (1954:91). It can be understood that discrimination is social problem which is distinguish people based on race, sex or religion. One of problem discrimination which appears in United States is race. racial discrimination is distinguish people based on different in physic such Jackson and Weidman state that race is a group of people that is distinguished by various physical features such as, skin color, eye shape, or hair color or texture. (2004: 251). Based on Nicholas, Jackson and Weidman opinion can be conclude that racial discrimination is treating people differently based on different in physic.

Furthermore, the phenomena of racial discrimination found in the literary work "To Kill a Mockingbird" is written by Harper Lee. There are several reasons, why the researcher chose novel "To Kill Mockingbird". Firstly, "To Kill a Mockingbird by Harper Lee" is kind of good American novel, it evidenced that "To Kill a Mockingbird novel" could win great critical acclaim, including the Pulitzer Prize for Fiction in 1961. It remains a bestseller with more than 30 million copies in print. In 1999, it was voted "Best Novel of the Century" in a poll by the Library Journal. lastly, Harper Lee expressed the story by giving serious issues and rapes, care to other people, moral, shelter are interesting to be discussed "To Kill a Mockingbird" is probably the most widely read book dealing race in America. The setting of the story takes place at the end of the great depression in small town of Maycom. The narrator, six years old Jean Louise Finch (Scout) lives in a world is shattered by her realization that is racism is rampant in her town and affect her family. Scout lives in country of Maycom, Alabama with her older brother Jem Finch, her widowed fatter Atticus Finch and the Africa-America nanny Calpurnia.

The story starts from Atticus Finch as white people defend Tom Robinson. The interesting point of story happens by Atticus who is from white people but he struggle to defend Tom Robinson who is accused of raping Mayella Ewell. Actually, He knows that, white people in the country protest with Atticus's defend Tom Robinson, because at the time, racial discrimination is high and most of the society have concept to do racial discrimination although probably black people do not do mistake. One of reason, why Atticus Finch defends Tom Robinson because Atticus Finch wants to give justice for people who do not do mistake

Based on all backgrounds above, the writer is interested to analyze the phenomena of racial discrimination, because the phenomenon of racial discriminations is the problem that still relates human being problem and interesting to be discussed.
