CHAPTER I

INTRODUCTION

1.1 The Background of the Research

Literature is a part of culture elements. It describes many aspects of human value, their problems, their thoughts, and also their conflicts. Many people are still confused about how to interpret the meaning of literature. Hornby states that literature is writings that are valued as works of art (1989:728). Semi also states that literature is one of creative art's form and work with the human being and their lives as the object by using language as its medium (1988:8). As the creative arts which uses human and everything in their life as the object. So, literature can be defined as the media to express the idea, theory and thinking system of human. They use their minds to express their feeling, emotion and thought to communicate with others. The result of this literature can be called as literary work.

When discussing about Literature, Eagleton states that the emergence of the concept literature is not limited on the creative writing and imaginative. He also states that literature is a worth writing in society, such as philosophy, history, essay, letters, and also poetry (Faruk, 1983:116). Eagleton says further that literature is more than just to accommodate the certain social values, literature is an important instrument which is strengthening and increasingly broad (1996:23). This Eagleton states more or less means that literature it is not only just to accommodate the certain social values, literature is accommodate the certain social values.

When discussion between literature and society derived from De Bonald states that literature is an expression of society (Wellek and Warren, 1956:95). Hornby states that poem is piece of creative writing in verse, especially one expressing deep feelings or noble thoughts (1989: 954). Based on the statement above more or less it can be conclude that poetry is piece of creative writing in verse which is produced within a context.

When discussing about lyrics, Kennedy and Gioia states that lyrics is a short poem expressing the though and feelings of a single speaker (2007:427). Hoeper and Pickering also states that song is a lyric poem set to the music (1990:44). It means that song is kind of a lyric poem joined with music. The lyrics itself are presented in written and spoken text generally in its album record.

Comparing to the other literary work, the researcher thinks that lyrics is more interesting than others literary works because it is interesting to be discussed since there are some people who like the songs not only because of their beats, but also some of those people like the songs because of the extreme choice of words in the lyrics, so the researcher thinks that this analysis can help the people to know

John Winston Lennon (born in Liverpool, England October 9, 1940 and died in New York City, USA, December 8, 1980 at the age of 40 years) was a singer, song writer, instrumental, writer, and political activist who were famous all over the world as the leader of The Beatles (John Lennon-a Biography: 2010:1).

Lennon began his career with The Beatles in 1960. This group released several albums, *Please Please Me* (March 1963), *With the Beatles* (November 1963), *A Hard Day's Night* (June 1964), *Beatles for Sale* (December 1964), *Help!* (August 1965), *Rubber Soul* (December 1965), *Revolver* (August 1966), *Sgt. Pepper's Lonely Hearts Club Band* (June 1967), *The Beatles* (November 1968)— aka, the *White Album,Yellow Submarine* (January 1969), *Abbey Road* (September 1969). During 1970 to 1975, John undergoing a solo career, with The album of the released such as, *John Lennon/Plastic Ono Band* (December 1970), *Imagine* (September 1971), *Some Time in New York City (with Yoko Ono)* (September 1972), *Mind Games* (November 1973), *Walls and Bridges* (October 1974), *Roots: John Lennon Sings the Great Rock and Roll Hits* (January 1975), *Rock 'n Roll* (February 1975), *Double Fantasy (with Yoko Ono)* (November 1980), *Milk and*

One of the best songs which are still popular is "Imagine". This song is a popular and phenomenal song because it is such kind the best-selling single of his solo career, its lyrical statement is one of collectivist positivisms. It challenges the listener to imagine a world at peace, without the divisiveness and barriers of religious denominations and nationalities, and to consider the possibility that the focus of humanity should be living a life less attached to material possessions. Lennon also dream's the world with no heaven or hell waiting for us. Lennon released Imagine as a single in the United Kingdom and it reached number six in the chart that year. The researcher assumes that "Imagine" tell the people to live in peace without any abuse, or war. The world where people live should always be in peace and harmony. Lennon also urged the people to imagine life in the world without religion, without nations, living in peace. Therefore, the researcher chooses this song interesting to be analysis more deeply.

In this song, there are many conflicts. In Jonas view, conflict is what gets the reader involved emotionally in what happening (1968:30). Furthermore, Pickering states that conflict may be either external, he classify when protagonist is against some external object or force internal, to be resolved is one within the protagonist's own self (1993:2). Based on Pickering, conflict divided into two types, internal and external.
