### **CHAPTER III**

#### **METHOD OF THE RESEARCH**

In this chapter the researcher wants to present the methodology that will use in writing process of her thesis. The researcher begins with the approach of the study. Then describes the source of the data and the last, the researcher present the data collection and data analyst.

### 3.1 Research design

The researcher is naturally descriptive qualitative as Maleleong defined that qualitative research is a scientific research that has a purpose to understanding the phenomenon in social context (Cresswell, 2003). In this thesis the researcher see the phenomenon of Unhomeness in The Sory of A Boxing Legend, and want to examine the subject's struggle to solve the phenomenon. This means that this research analyzes the data by describing data in details. At the same time, this research is qualitative because the data are not form in numeric, but they are form of word, phrase, or utterance or sentences.

A research design is a plan or procedure that the researcher conduct before analyzing the data to answer the research question.
